7. My efforts to have the hood corrosion problem repaired are detailed in the accompanying documents and photographs, but I continue to be concerned that the problem will reappear.

8. In my opinion, the hood corrosion problem is obvious and serious enough to reduce my car's resale / trade-in value.

9. I have followed the case and reports of Mustang hood corrosion problems online and would like to see Ford provide relief to owners of the affected cars.
